| <b>Initial</b> | <p>I am participating in the Victoria Kids Consignment Sale as a Seller or Volunteer.<br/>I agree to allow Victoria Kids Consignment to sell any and all items registered with a VKC Sale event.<br/>I am responsible for designating the sales price for my items.</p>   |
| <b>Initial</b> | <p>I am the sole owner of the items I bring to the sale and have the full authority to sell them.<br/><b>I understand there is a limit of 100 articles of clothing within the overall limit of 350 items.</b><br/>I agree I am not consigning items with a friend or on behalf of another party.<br/>Every item I bring to the sale complies with applicable law, as defined by Health Canada:<br/><a href="http://www.hc-sc.gc.ca/cps-spc/index-eng.php">http://www.hc-sc.gc.ca/cps-spc/index-eng.php</a>.<br/>Every item I bring to the sale has been checked for pending recall notices or other consumer protection enforcement action.</p>   |
| <b>Initial</b> | <p>I understand if I tag my items 'Discount: Yes' they may be sold for 50% less than the tagged price during the Half-Price Sale.<br/>I understand if I tag my items 'Donate' any unsold items will be donated by VKC.<br/>I understand if I tag my items as 'No Donate' I must collect my unsold items between 3:00-4:00 PM on September 22, 2024.<br/>I understand if I do not return to collect my unsold, non-donated items by 4:00pm September 22 2024, they will be donated by VKC.<br/>I understand if I tag my items as 'No Donate' AND I do not collect them between 3:00-4:00PM on September 22 2024, my e-transfer payout will be reduced by \$25 for a no-show fee.</p>   |
| <b>Initial</b> | <p>I understand VKC will charge GST &amp; PST on the merchandise and remit the appropriate amounts to Canada Revenue Agency.</p>  |
| <b>Initial</b> | <p>I understand the following seller pay structure:<br/>I will earn 60% of the gross sales price for my items, less a \$15 registration fee, <b>if I am unable to volunteer.</b><br/>I will earn 65% of the gross sales price for my items, less a \$15 registration fee, <b>if I volunteer for one (1) shift.</b><br/>I will earn 70% of the gross sales price for my items, less a \$15 registration fee, <b>if I volunteer for two (2) shifts.</b><br/>I will earn 75% of the gross sales prices for my items, less a \$15 registration fee, <b>if I volunteer for three (3) shifts.</b><br/>If I qualify for the Early Bird Discount, my registration fee will be \$10 instead of \$15. (Early Bird registration is valid for 24hrs after registration opens. <b>*Valid from 8:00am July 1-2<sup>nd</sup>, 2024.*</b><br/>I will receive one (1) Volunteer Presale Pass for the Volunteer Presale September 20, 2024- <b>IF I VOLUNTEER.</b><br/>I will receive one (1) Seller Presale Pass for the Seller Presale September 20, 2024. <b>IF I DROP OFF MY ITEMS.</b></p> |
